1. **Introduction** 1.1 Please read these Terms of Service ("Terms", "Terms of Service") carefully before using the Divinitycraft.org website (the "Service") operated by Divinitycraft ("us", "we", or "our"). 1.2 Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users, and others who access or use the Service.
2. **Conditions of Use** 2.1 By accessing the website at Divinitycraft.org, you are agreeing to be bound by these terms of service, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. 2.2 If you do not agree with any of these terms, you are prohibited from using or accessing this site.

5. **Refund Policy** 5.1 Due to the nature of digital goods, all sales are final. We do not offer refunds or exchanges once a purchase has been made, except as outlined in section 4.5. 5.2 Any claims for non-delivery of digital goods must be submitted to us in writing within 7 days from the order placing date.
